**CONFIRMATORY GRANT OF SECURITY INTEREST  
IN UNITED STATES TRADEMARKS**

This CONFIRMATORY GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS (as the same may be amended, restated, supplemented or otherwise modified from time to time, the “Confirmatory Grant”) is made effective as of July 29, 2022 by and from (i) BEP Borrower Holdco, LLC, a Delaware limited liability company (“Borrower”), (ii) ArrowStream, Inc., a Delaware corporation, (iii) Buyers Edge Platform OpCo, LLC, a Florida limited liability company, (iv) Consolidated Concepts, LLC, a Massachusetts limited liability company, (v) Dining Alliance, LLC, a Massachusetts limited liability company and (vi) Produce Alliance, L.L.C., an Illinois limited liability company (the entities listed in items (i) through (vi), each a “Grantor” and together, the “Grantors”) to and in favor of JPMORGAN CHASE BANK, N.A., for itself and as Administrative Agent for the Secured Parties (as defined in the Credit Agreement referenced below) (in such capacities, “Grantee”).

WHEREAS, Borrower, the Lenders and Grantee have entered into a Credit Agreement dated as of July 29, 2022 (as may be amended, restated, supplemented or otherwise modified from time to time, the “Credit Agreement”).

WHEREAS, the Grantors and certain other Subsidiaries of Borrower have entered into a Guarantee and Collateral Agreement dated as of July 29, 2022 (as may be amended, restated, supplemented or otherwise modified from time to time, the “Guarantee and Collateral Agreement”).

WHEREAS, each Grantor owns the trademarks listed on Exhibit A attached hereto (the “Trademarks”), which Trademarks are pending or registered with the United States Patent and Trademark Office.

WHEREAS, this Confirmatory Grant has been granted in conjunction with the security interest granted under the Guarantee and Collateral Agreement to Grantee for the benefit of the Secured Parties. The rights and remedies of Grantee with respect to the security interest granted herein are without prejudice to and are in addition to those set forth in the Guarantee and Collateral Agreement and the other Loan Documents, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Confirmatory Grant are deemed to conflict with the Guarantee and Collateral Agreement, the provisions of the Guarantee and Collateral Agreement shall govern.

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is hereby agreed that:

Definitions. All capitalized terms not defined herein shall have the respective meaning given to them in the Credit Agreement or the Guarantee and Collateral Agreement, as applicable.

Grant of Security Interest. Each Grantor hereby assigns and transfers to the Grantee and hereby grants to Grantee for the ratable benefit of the Secured Parties, a security interest in all of the Trademarks now owned or at any time hereafter acquired by such Grantor or in which such Grantor now has or at any time in the future may acquire any right, title or interest, including without limitation the Trademarks listed on Exhibit A hereto.

Counterparts. This Confirmatory Grant may be executed in any number of counterparts and by different parties in separate counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Signature pages may be detached from multiple separate counterparts and attached to a single counterpart.

Governing Law. This Confirmatory Grant and the rights and obligations of the parties hereto shall be construed in accordance with and governed by the law of the State of New York.


