**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of December 20, 2023 (“Release”), is made by Blue Torch Finance LLC as Collateral Agent (“Collateral Agent”) in favor of Cancos Tile & Stone LLC (“Cancos”) and UMI, LLC (“UMI”, and together with Cancos, collectively, the “Assignors”),

**WHEREAS**, pursuant to that certain Pledge and Security Agreement (as amended, restated, supplemented or otherwise modified from time to time, the “Pledge and Security Agreement”), dated as of July 15, 2022, by and among each Assignor, Collateral Agent, and others party thereto, and the Intellectual Property Security Agreement dated as of July 15, 2022 by and among each Assignor and Collateral Agent (“Trademark Security Agreement”), Each Assignor granted to the Collateral Agent, for the ratable benefit of the Secured Parties, a security interest in all of such Assignor’s right, title and interest in, to and under the Collateral; and

**WHEREAS**, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) on July 15, 2022 at Reel 007789 Frame 0350.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent, on behalf of the Secured Parties, and each Assignor agree as follows:

**SECTION 1. Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Pledge and Security Agreement or Trademark Security Agreement, as applicable.

**SECTION 2. Termination and Release.** Collateral Agent, on behalf of the Secured Parties, without any representation, warranty, recourse, or undertaking of any kind (whether express or implied), hereby:

(a) terminates, cancels, discharges, and releases the security interest in all of each Assignor’s right, title and interest in, to and under the Trademarks of such Assignor, including, but not limited to, the Trademarks listed on Schedule A attached hereto, granted pursuant to the Pledge and Security Agreement or Trademark Security Agreement;

(b) grants, assigns and conveys to each Assignor all of the rights, title and interest in the Trademarks of such Assignor; and

(c) authorizes the recordation of this Release with the USPTO at each Assignor’s expense.

**SECTION 3. Choice of Law.** This Release shall be governed by and construed in accordance with the laws of the State of New York.

**IN WITNESS WHEREOF**, the Collateral Agent, on behalf of the Secured Parties, has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.
