PARTIAL RELEASE OF TRADEMARK SECURITY AGREEMENT AND OTHER INTELLECTUAL PROPERTY

THIS PARTIAL RELEASE OF TRADEMARK SECURITY AGREEMENT (this “Partial Release”), is dated as of February 9, 2024, and made by BLUE TORCH FINANCE LLC, as Collateral Agent for itself and the other lenders (the “Assignee”), in favor of LSC COMMUNICATIONS MCL LLC (the “Assignor”).

WHEREAS, pursuant to that certain (i) Pledge and Security Agreement, dated May 4, 2022 (as amended, restated, supplemented, modified or otherwise changed from time to time, the “Security Agreement”), by and among the Assignor, the other Loan Parties party thereto and Assignee and (ii) the Notice of Security Interests- Trademarks, dated as of May 4, 2022 (the “Notice of Trademarks”) made by the Assignor in favor of the Assignee, the Assignor granted a security interest to the Assignee in certain collateral, including the Released Trademarks (as defined hereafter) and certain unregistered trademarks, domain names and software (the “Other Intellectual Property”, as more fully identified in Exhibit A) ;

WHEREAS, the Notice of Trademarks was recorded at the United States Patent and Trademark Office on May 4, 2022 at Reel/Frame 7712/0388; and

WHEREAS, the Assignee now desires to release the Released Trademarks (as defined hereafter) and the Other Intellectual Property to Assignor, as set forth herein.


NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Partial Release, the Assignee hereby releases and discharges its lien on and security interest solely in the registered trademarks (the “Released Trademarks”) and Other Intellectual Property listed on Exhibit A and the hereto and reassigns to Assignor all right, title and interest of Assignee in the Released Trademarks and Other Intellectual Property (including but not limited to applications and registrations thereof, goodwill of the business symbolized thereby, all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present, and future violations thereof). The Assignee agrees that any power of attorney or similar rights granted by Assignor to Assignee pursuant to or in connection with the Security Agreement or Notice of Trademarks as to the Released Trademarks and Other Intellectual Property listed on Exhibit A is hereby terminated. The Assignee authorizes the recordation of this Partial Release with the United States Patent and Trademark Office.
