SECURED PARTY BILL OF SALE AND TRANSFER STATEMENT

Seller **PETER K. TRZYNA**, in consideration of being holder of a perfected security interest and the successful bidder at a sale conducted pursuant to Section 9-610 of the Uniform Commercial Code (the "UCC"), does hereby sell, assign, transfer and set over to himself as Purchaser, the following described personal property listed and described on the Asset List attached as Exhibit A hereto and made a part hereof (the "Assets").

WHEREAS, on or about April 13, 2006, the Debtors, Ari Sklar ("Sklar") and Acquire Systems, Inc. ("Acquire") (collectively referred to as "Debtors"), entered into a written retention letter with Peter K. Trzyzna ("Trzyzna") wherein Debtors granted Trzyzna a lien on the Assets as security for payment of attorneys' fees incurred by them;

WHEREAS, on December 13, 2010, Trzyzna filed a UCC Financing Statement with the New York Department of State, Uniform Commercial Code Division, naming Acquire as the debtor, covering the Assets;

WHEREAS, the Debtors, individually and collectively, defaulted in connection with their obligation to Trzyzna to pay attorneys' fees incurred by them;

WHEREAS, Trzyzna exercised his post-default remedies with respect to the Assets by conducting a Public Sale of the Assets on June 6, 2013 and serving notice of the sale to all parties who may claim a right, title, interest, or lien in or to the Assets as more fully set forth on the attached service list attached hereto as Exhibit B;

WHEREAS, Trzyzna was the only party to appear at the Public Sale of Assets on June 6, 2013;

WHEREAS, Trzyzna bid his claim in the amount of \$62,339.67, for the Assets;

WHEREAS, by reason of Trzyna's successful bid for the Assets, Trzyna transferred all Debtors' rights, title, and interest in and to the Assets to himself as highest bidder at the Public Sale held on June 6, 2013;

THEREFORE, the Assets are free and clear of all liens and without warranties.

IN WITNESS WHEREOF, Seller has caused this Secured Party Bill of Sale and Transfer Statement to be signed this 28 day of June 2013.



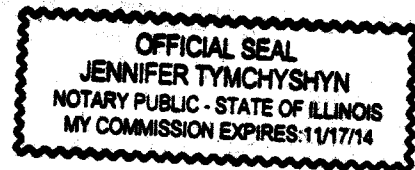
