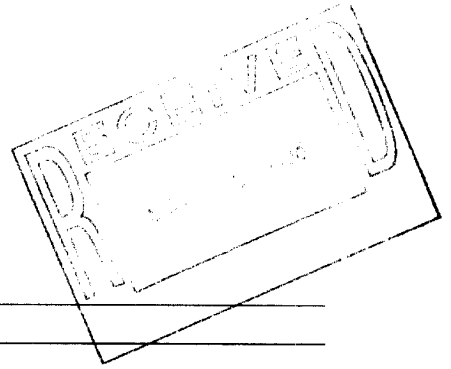

OF TRADEMARKS**



Fleet hereby acknowledges and confirms that effective as of the date hereof, Fleet hereby releases and relinquishes its entire right, title and interest in and to the Trademarks, and agrees that the Collateral Assignment of Trademarks is hereby cancelled and terminated in all respects and of no further force or effect.
