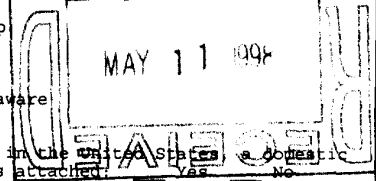

**TERMINATION OF COLLATERAL ASSIGNMENT
OF COPYRIGHTS, PATENTS AND TRADEMARKS**

THIS TERMINATION OF COLLATERAL ASSIGNMENT OF COPYRIGHTS, PATENTS, AND TRADEMARKS (this "Termination") is made and delivered as of the 18th day of December, 1992, by and between Bridgeport Machines, Inc., a Delaware corporation with its principal place of business at 500 Lindley Street, Bridgeport, Connecticut 10060 (the "Assignor"), and The Chase Manhattan Bank, N.A., 1 Chase Manhattan Plaza, New York, New York 10081, as agent for itself and the banks party to that certain Credit Agreement, dated as of March 28, 1990 (the "Assignee"), as holder of a certain Collateral Assignment of Copyrights, Patents, and Trademarks (the "Collateral Assignment"), recorded in the Patent and Trademark Office in Washington, DC, in reel 5278, beginning at frame 643-656.

WITNESSETH:

WHEREAS, on March 28, 1990, the Assignor executed and delivered the Collateral Assignment to the Assignee as collateral for the Assignor's loan obligations to the Assignee; and

WHEREAS, the Assignor has requested the Assignee to release the Collateral Assignment and the Assignee has agreed to do so.
