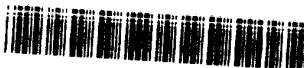

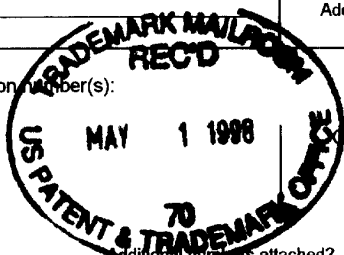

## ASSIGNMENT AND ACCEPTANCE


Reference is made to the Collateral Assignment of Trademark License Agreement (the "Collateral Assignment") made as of September 8, 1994, between Altec Lansing Technologies, Inc., f/k/a Sparkomatic Corporation and BTM Capital Corporation, f/k/a BOT Financial Corporation, a Delaware corporation (the "Assignor") and recorded in the U.S. Patent and Trademark Office at Reel 1220 frame 222-259. Capitalized terms used by not defined herein shall have the meanings assigned to such terms in the Collateral Assignment.

The Assignor, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and PNC Bank, National Association, a national banking association (the "Assignee") hereby agree as follows:


1. The Assignor hereby sells and assigns to the Assignee, and the Assignee hereby purchases from the Assignor and assumes, all of the Assignor's rights and obligations under the Collateral Assignment as of the Effective Date (as defined below) including all right, title and interest in and to the License Agreement by and between Sparkomatic Corporation and Altec Lansing Corporation, dated as of November 5, 1985, as supplemented, modified and amended from time to time, and all rights corresponding thereto, including certain rights to use the trademarks listed on Exhibit A and the goodwill associated therewith.
2. The Assignee and Assignor agree that the liability of each of them under this Assignment and Acceptance and any other agreement, document, certificate or instrument delivered by either, or under any law applicable to the Collateral Assignment or the assignment thereof, shall be limited as provided in Article IX of the Purchase Agreement entered into as of March 17, 1998, between Assignor and Assignee.
3. The effective date of this Assignment and Acceptance shall be April 15, 1998 (the "Effective Date").
4. This Assignment and Acceptance shall be governed by and construed in accordance with the laws of the Commonwealth of Massachusetts.
5. This Assignment and Acceptance may be executed in any number of counterparts, each of which shall be deemed an original and which together shall constitute one instrument.




