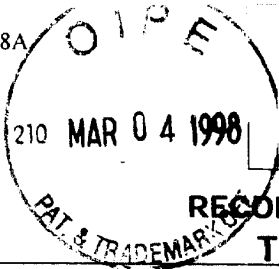

**TERMINATION OF SECURITY INTEREST IN TRADEMARKS**

WHEREAS, Selfcare Acquisition Corp., whose name has been changed to Selfcare Consumer Products, Inc. by a Certificate of Amendment to its Certificate of Incorporation dated as of September 26, 1997 ("Debtor") has satisfied in full all of Debtor's obligations to Fleet National Bank, as agent, acting for itself and other lenders ("Secured Party") under the Credit Agreement dated February 19, 1997 and the Trademark and Service Mark Security Agreement dated February 19, 1997, thereby terminating the Security Interest of Secured Party; and

2. Secured Party hereby authorizes and requests the Commission of Patents and Trademarks of the United States, to record the release and termination of the Security Interest in the Collateral by Secured Party, its successors, legal representatives and assigns.
