ASSIGNMENT OF TRADEMARK RIGHTS

WHEREAS SEAGATE TECHNOLOGY, INC., a Delaware corporation (hereinafter referred to as "ASSIGNOR"), has adopted, used in its business and is the owner of the entire worldwide right, title and interest in and to the trademarks set forth in the attached Exhibit A for the goods set forth in the federal trademark registration and applications identified in Exhibit A ("said Marks"), the goodwill appurtenant to said Marks, and the United States Trademark Registration and Applications for said Marks;

WHEREAS SEAGATE SOFTWARE, INC., a Delaware corporation, (hereinafter referred to as "ASSIGNEE"), is a subsidiary of ASSIGNOR in which ASSIGNOR owns a majority of the voting stock of ASSIGNEE and thereby controls the nature and quality of the goods and services sold by ASSIGNEE;

WHEREAS ASSIGNEE is desirous of acquiring ASSIGNOR's entire right, title and interest in and to said Marks, the appurtenant goodwill, the federal trademark registration and applications for said Marks and the rights at common law in and to said Marks;

WHEREAS ASSIGNOR has trademark registrations and has filed trademark applications, identified in the attached Exhibit A, in the United States Patent and Trademark Office, and ASSIGNOR has caused ASSIGNEE to file certain trademark applications for the Marks in foreign countries in the name of ASSIGNEE;

WHEREAS ASSIGNOR now desires to assign the legal title in and to the Marks and trademark registrations and applications in the United States and other countries to ASSIGNEE, subject to a right of reversion to ASSIGNOR if there is a "Change of Control of ASSIGNEE" so that use of the Marks by ASSIGNEE will continue to inure to the benefit of ASSIGNOR, notwithstanding the holding of legal title in and to the Marks throughout the world by ASSIGNEE;

WHEREAS, as used herein, the expression "Change of Control of ASSIGNEE" shall mean that 1) ASSIGNOR no longer has elected more than 50% of the members of the Board of Directors of ASSIGNEE, or an equivalent governing body of ASSIGNEE; or 2) ASSIGNOR no longer owns more than 50% of the outstanding shares of stock entitled to vote for the Board of Directors of ASSIGNEE or the equivalent governing body of ASSIGNEE;

WHEREAS, as used herein the expression "NOTICE" shall mean ASSIGNOR, in its sole discretion, gives written notice to ASSIGNEE that ASSIGNOR elects to have said Marks assigned back to ASSIGNOR under ASSIGNOR's right of reversion;

WHEREAS, ASSIGNOR may elect not to exercise its right to reversion if ASSIGNOR believes that it has control in fact, of the Board of Directors of ASSIGNEE, or an equivalent governing body of ASSIGNEE;

NOW, THEREFORE, in consideration of the premises, the sum of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged;

Effective October 1, 1997, ASSIGNOR agrees to sell, assign, transfer and convey, and by this instrument hereby sells, assigns, transfers and conveys to ASSIGNEE, its successors, legal representatives and assigns, ASSIGNOR's entire worldwide right, title and interest in and to each of said Marks identified in Exhibit A, the goodwill of the business appurtenant to and connected with said Marks, the United States Trademark Registration and Applications for said Marks, and all rights at common law in said Marks; and ASSIGNOR further assigns, transfers, sells and conveys to ASSIGNEE, its successors, legal representatives and assigns, the right to apply for, register, renew, protect, defend and enforce any and all rights worldwide to the said Marks including the right to sue for past infringement, the right to enforce any and all trademark rights of ASSIGNOR and causes of action therefor, presently known or unknown and inuring to ASSIGNEE, and the right to recover all claims for damages or for compensation for past infringement arising out of any cause of action, whether presently known, unknown, accrued or to accrue; such assignment of rights in said Marks and all foreign trademark registrations obtained for said Marks, and all foreign trademark applications filed for said Marks being expressly subject to automatic reversion, reconveyance and reassignment from ASSIGNEE back to ASSIGNOR upon the occurrence for any reason of the following conditions subsequent, namely, a Change of Control of ASSIGNEE and ASSIGNEE receives NOTICE.

ASSIGNOR agrees to cooperate fully with ASSIGNEE (at no cost to ASSIGNOR) in connection with perfecting the transfer of all rights to and the vesting of full and complete title in ASSIGNEE. ASSIGNOR agrees further to cooperate fully with ASSIGNEE (at no cost to ASSIGNOR) in connection with enforcing and defending the rights transferred and particularly in connection with executing any and all instruments deemed by ASSIGNEE to be necessary or desirable to implement and accomplish the transfer, enforcement and/or defense of rights granted by ASSIGNOR hereunder.

While reconveyance of said rights shall be automatic and instantaneous in the event that a Change of Control of ASSIGNEE occurs and ASSIGNEE receives NOTICE, ASSIGNEE agrees to execute the Assignment of Trademark Rights attached hereto as Exhibit B reconveying such rights in the Marks to ASSIGNOR to enable recording in the United States Trademark Office and in trademark offices throughout the world. ASSIGNEE further agrees that, in the event that a Change of Control of ASSIGNEE occurs and ASSIGNEE receives NOTICE, ASSIGNEE shall assign, transfer and convey to ASSIGNOR ASSIGNEE's entire right, title and interest in and to any other mark or trade name of ASSIGNEE throughout the world that includes the word "SEAGATE", including the trade name SEAGATE SOFTWARE, INC., and the goodwill of the business appurtenant to and connected therewith. ASSIGNEE shall promptly cease using the mark and word "SEAGATE" as part of its trade name and any trademarks or

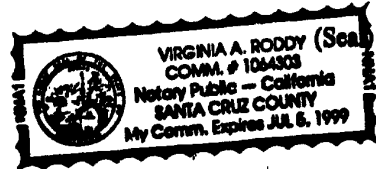

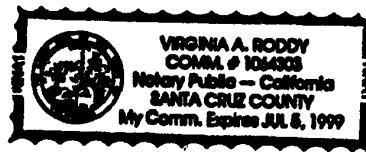
