PARTIAL RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS PARTIAL RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Partial Release"), dated as of May 15, 1998, is executed by WELLS FARGO BANK, NATIONAL ASSOCIATION ("Lender") in light of the following facts:

RECITALS

A. The Outdoor Recreation Group ("Debtor") and Lender are parties to a certain Trademark Security Agreement, dated as of January 22, 1998 (the "Security Agreement"), which was filed with the U.S. Office of Patents and Trademarks on March 6, 1998 in Reel/Frame 1696/0143, pursuant to which Debtor granted Lender a security interest in the "Collateral" referred to in such Security Agreement, which includes various trademarks specified therein, as collateral security for the payment and performance of Debtor's obligations to Lender under that certain Loan Agreement, dated as of January 22, 1998, by and between Debtor and Lender (the "Loan Agreement").

B. Debtor and Lender inadvertently specified the wrong application/registration number in the Security Agreement with respect to one of the trademarks covered thereby, and wish to release the recording only against the incorrect trademark from the Security Agreement as recorded in the records of the U.S. Office of Patents and Trademarks, so as not to impair the title of the owner of the "Campus Address" mark, bearing application no. 75-241,397 and registration no. 2,150,573 (the "Incorrect Trademark"), which was the trademark incorrectly referred to in the Security Agreement.

NOW, THEREFORE, Lender hereby releases the above referenced Incorrect Trademark from the Security Agreement. Nothing contained in this Partial Release in any way releases or terminates the security interest claimed by Lender as to the other trademarks, now owned or hereafter acquired by Debtor, subject to the Security Agreement.
