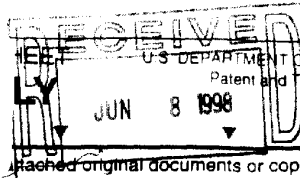



ASSIGNMENT OF PATENT AND TRADEMARK SECURITY AGREEMENT




