**TERMINATION AND RELEASE OF SECURITY INTEREST
IN U.S. TRADEMARKS**

WHEREAS, WINDY HILL PET FOOD COMPANY, INC., a Delaware corporation, having an address of Two Maryland Farms, Suite 301, Brentwood, Tennessee 30737 ("Windy Hill"), owns the U.S. trademark registrations listed on Schedule A (hereinafter the "U.S. Trademark Registrations");


WHEREAS, pursuant to a Trademark Security Agreement, dated as of April 29, 1996, recorded in the U.S. Patent and Trademark Office at Reel 1460, Frame 0486 on May 14, 1996 (hereinafter the "Security Agreement"), Windy Hill granted a security interest in the U. S. Trademark Registrations to NATIONSBANK OF TENNESSEE, N.A., a national banking association having an address of One NationsBank Plaza M-2, Nashville, Tennessee 37239, as Administrative Agent for the lenders (the "Administrative Agent") under the credit agreement (the "Credit Agreement"), dated as of April 29, 1996, by and among Windy Hill, Windy Hill Pet Food Holdings, Inc., a Delaware corporation ("Holdings"), the subsidiaries of Holdings and Windy Hill, PNC Bank, National Association as documentation agent for the lenders thereto (the "Lenders"), and the Lenders; and

WHEREAS, said Security Agreement was granted to secure loans made under the Credit Agreement by the Lenders to Windy Hill and said loans have now been paid in full;

NOW, THEREFORE, for good and valuable consideration, the Administrative Agent hereby terminates and releases any and all security interests it held on behalf of the Lenders under the Security Agreement in the U.S. Trademark Registrations, and the Administrative Agent no longer claims any security interest in said U.S. Trademark Registrations.
