**TRADEMARK ASSIGNMENT**

NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration, receipt of which is hereby acknowledged, Brandon does hereby sell, assign and transfer unto Kellwood the entire right, title and interest in and to:

The United States trademark registrations, together with the good will of the associated business, which are listed on Schedule A attached hereto and made a part of this Assignment, all causes of action, past, present and future for infringement or unfair competition with respect thereto and all licenses relating thereto.

Brandon warrants that it owns all rights without encumbrance in the United States trademarks covered by the registrations set forth in Schedule A attached hereto. Brandon hereby agrees that it will, upon written request of Kellwood, from time to time, execute reasonable documents prepared at the expense of Kellwood meeting the requirements of the United States Patent and Trademark Office to record or register Kellwood's rights in such trademarks.
