

AND, FMC hereby agrees to execute or cause to be executed any and all further papers which may be necessary or desirable to perfect the title of Hudson-Sharp, its successors and assigns, in and to the Trademarks.

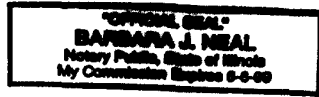
