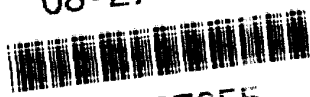

ASSIGNMENT OF TRADEMARKS

THIS ASSIGNMENT OF TRADEMARKS (Assignment) is executed this 1st day of July, 1998 by NAMICO, INC., a Pennsylvania corporation with offices at 4601 Flat Rock Road, Philadelphia, Pennsylvania, 19127, (Assignor) in favor of CARROLL COMPANY, a Texas corporation with offices at 2900 W. Kingsley Road, Garland, Texas, 75041, (Assignee).

WITNESSETH:

WHEREAS, Assignor and Assignee are parties to a certain Acquisition Agreement dated July 1, 1998, whereby Assignor has covenanted to assign to Assignee its trademarks as provided for herein and as identified in Schedule A and Schedule B attached hereto.

NOW THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged:

1. Assignor hereby warrants that (i) it has the full right and power to make the assignment of the marks made hereby, including, without limitation, the trademark registrations listed on Schedule A hereto, and the applications therefore or any common law rights to marks listed on Schedule B hereto (collectively, along with the registered trademarks listed on Schedule A, the "Marks"), (ii) all of the Marks are valid, subsisting, and enforceable, and (iii) Assignor has made no previous assignment, transfer, or agreement in conflict herewith or constituting a present or future assignment of or encumbrance on any of the Marks.

2. Assignor hereby grants, assigns, and conveys to Assignee its entire right, title, and interest in and to the Marks, including, without limitation, all renewals therefor, all proceeds therefor (including, but not limited to, all license royalties and proceeds of infringement suits), the right to sue for past, present, and future infringements, and the goodwill of the business associated with and symbolized by each of the Marks.

3. This Assignment may not be altered, amended, or modified except by a writing signed by both Assignor and Assignee. This Assignment shall be binding upon Assignor and its successors and assigns, and shall inure to the benefit of the Assignee and its successors and assigns. This Assignment shall be governed by and construed in accordance with the applicable laws of the United States of America.

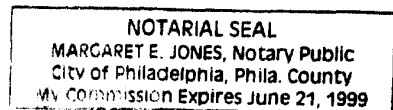
