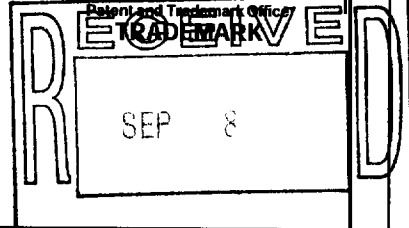

BILL OF SALE

KNOW ALL MEN BY THESE PRESENTS, that pursuant to that certain Asset Purchase Agreement between Tuneco, Inc., a Georgia corporation ("Seller") and Express Oil Change, L.L.C., a Delaware limited liability company ("Buyer"), made as of the 19th day of March, 1998 (the "Agreement"), Seller, for valuable consideration paid to it by Buyer, the receipt and sufficiency of which are hereby acknowledged, does hereby sell, convey, transfer, assign, set over and deliver to Buyer, all of the following described assets (personal, tangible and intangible) relating to those oil change centers purchased by Buyer and listed on Exhibit "A" hereto and owned or leased by Seller as of the Closing Date (the "Express Oil Centers"):

a. tangible personal property, including all machinery, equipment, inventories, inventories on order, manufactured and purchased parts, goods in process and finished goods, furniture, automobiles, trucks, tractors, trailers, tools, jigs and dies located at each of the Express Oil Centers owned or leased by the Seller (the "Personal Property");

b. intellectual property, including the exclusive ownership of and right to use the name "Tune-Up Clinic" and all derivations thereof and all tradenames, trademarks, service marks, copyrights and applications thereof, including, without limitation, those described in Exhibit "B" hereto, goodwill associated therewith, licenses and sublicenses granted and obtained with respect thereto, and rights thereunder, remedies against infringements thereof, and rights to protection of interests therein under the laws of all jurisdictions;

c. all rights, title and interests of Seller under the leases described in Exhibit "C" hereto (the "Leases");

d. all interests of Seller under the Acquired Contracts (as defined in the Asset Purchase Agreement) and relating to the Express Oil Centers;

e. franchises, approvals, permits, licenses, orders, registrations, certificates, variances, and similar rights obtained from governments and governmental agencies, to the extent that Seller is permitted under the terms thereof to transfer such items; and

f. all plats, architectural plans, surveys, drawings and specifications for the Express Oil Centers, and all creative materials, advertising and promotional materials.

Provided, however, that none of the Excluded Assets (as defined in the Agreement) are being conveyed to the Buyer pursuant to this Bill of Sale.

TO HAVE AND TO HOLD the same unto Buyer, its successors and assigns, forever.

Unless otherwise indicated, capitalized terms used but not defined herein shall have the respective the respective meanings ascribed to them in the Agreement. This Bill of Sale shall be subject to the terms and conditions of the Agreement. In the event of any conflict or inconsistency between the terms of this Bill of Sale and the Agreement, the terms of the Agreement shall govern.

IN WITNESS WHEREOF, Seller has caused this Bill of Sale to be executed on its behalf by its duly authorized officers as of the 7 day of May, 1998.

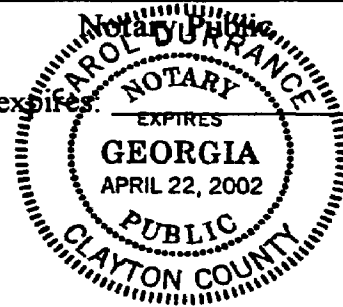
