W I T N E S S E T H

WHEREAS, Assignor, Assignee, and certain other identified parties have entered into a General Assignment, Bill of Sale, Assumption of Liabilities and Agreement, dated as of the 31st day of December, 1995, as it may be amended from time to time pursuant to the terms thereof (the "Agreement"), pursuant to which Assignor has agreed to assign, transfer and convey to Assignee certain assets; and

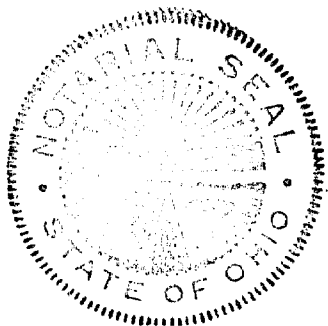
