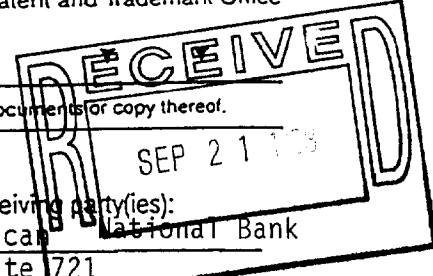


Dear Mr. Taylor:
