ASSIGNMENT OF TRADEMARKS (the "Assignment") made by THERMAL TRANSFER CORPORATION, a Pennsylvania corporation ("Assignor"), having a principal place of business at 1100 Rico Road, Monroeville, PA 15146 to Hamon D'hondt S.A., a Belgium corporation ("Assignee"), having a principal place of business at Rue de Wasmes 120/2, B-7301 Hornu, Belgium.

WHEREAS, Hamon & CIE (International) S.A. ("Hamon") and Air & Water Technologies Corporation are parties to an Asset and Stock Purchase Agreement, dated as of June 6, 1998 (the "Agreement") (capitalized terms used herein without definition shall have the meanings set forth therein), providing for the execution and delivery of this Assignment by a Purchasing Subsidiary designated by Hamon;

WHEREAS, Assignor has adopted, used and is using the marks set forth on Schedule I hereto and incorporated by reference herein, which are registered in, or for which application for registration has been filed in, the United States Patent and Trademark Office and other marks, including but not limited to those set forth on Schedule I (the "Assigned Marks"); and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee agree as follows:

Assignor does hereby sell, transfer, convey, assign and deliver to Assignee all right, title and interest of Assignor in and to the Assigned Marks, the registrations and applications for registrations thereof, and the goodwill of the business connected with the use thereof and symbolized thereby, free and clear of all Liens, other than Permitted Liens; all rights of priority therein in any country as may now or hereafter be granted to it by law, treaty or other international convention; and all rights, interests, claims and demands recoverable in law or equity, that Assignor has or

may have in profits and damages for past, present and future infringements of the Assigned Marks, including, without limitation, the right to compromise, sue for and collect such profits and damages; the same to be held and enjoyed by Assignee, its successors and assigns or their legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made.

Assignor hereby agrees that Assignor shall and shall cause each of its affiliates to, from time to time, execute and deliver to Assignee such additional instruments, documents, conveyances or assurances and take such other actions as shall be necessary, or otherwise reasonably requested by Assignee, to confirm and assure the rights and obligations provided for in the Agreement and render effective the consummation of the transactions contemplated hereby and thereby.

This Assignment shall be governed by, and construed in accordance with, the laws of the United States in respect to trademark issues and, in all other respects, including as to validity, interpretation and effect, the laws of the State of New York, without giving effect to the conflict of laws rules thereof.
