TRADEMARK RELEASE

THIS TRADEMARK RELEASE is made as of the 6 day of November, 1998, by FLEET CAPITAL CORPORATION (formerly known as Shawmut Capital Corporation) (formerly known as Barclay's Business Credit, Inc.) (the "Secured Party") in favor of COMDIAL BUSINESS COMMUNICATIONS CORPORATION, a Delaware corporation (the "Grantor");

WITNESSETH:


