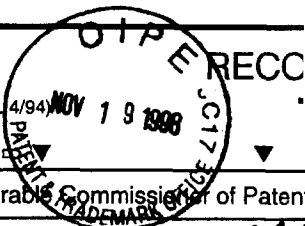

**TRADEMARK ASSIGNMENT**


