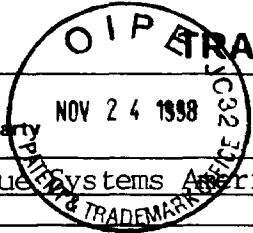

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, Assignors agree as follows:

1. Assignment of Registered Marks. Assignors do hereby assign unto Assignee all right, title and interest in and to the marks which are described on Exhibit A, together with the goodwill of the business symbolized by such marks, and the registration of such marks shown on Exhibit A.



3. Governing Law. This Assignment shall be governed by and construed in accordance with the internal laws of the State of New York (without reference to the choice of law provisions of New York law).






