NOTICE OF RELINQUISHMENT
OF ASSIGNMENT OF SECURITY INTEREST
(Trademarks)

WHEREAS, an Assignment of Security Interest (Trademarks), dated as of October 4, 1996 (the "Assignment"), was made by THE CHASE MANHATTAN BANK (formerly known as CHEMICAL BANK) ("Chemical" or the "Assignor"), in favor of MORGAN GUARANTY TRUST COMPANY OF NEW YORK, as Agent ("Morgan" or the "Assignee"), pursuant to, and in conjunction with, the Credit Agreement dated as of October 10, 1996 among Morgan, Metro-Goldwyn-Mayer Inc. (now known as "Metro-Goldwyn-Mayer Studios Inc.") (the "Company") and the lenders signatories thereto;

WHEREAS, pursuant to the Assignment, Chemical assigned to Morgan all of its right, title and interest in and to the security interest in, to and under the Trademarks listed in the attached Schedule A, as set forth in the Company Security Agreement between the Company and Chemical dated as of September 16, 1994 and Supplements thereto as referenced in the Assignment;

WHEREAS, the Assignment was recorded in the United States Patent and Trademark Office as of November 7, 1996 at Reel 1526, Frame 1, et seq.;

WHEREAS, the Assignee in its capacity as Agent, wishes to release any and all interest it may have in, to and under the Trademarks listed in the attached Schedule A;

WHEREAS, the parties desire to provide a document suitable for recording in the United States Patent and Trademark Office for the purposes of recording the release, relinquishment and discharge by the Assignee of all of its rights and interests in the Trademarks listed in the attached Schedule A pursuant to the Assignment, as set forth in the Company Security Agreement and the Supplements thereto referenced in the Assignment;

NOW, THEREFORE, in consideration of and in exchange of good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignee hereby relinquishes, releases and discharges all rights and interests assigned to it pursuant to the Assignment, including without limitation, its security interest in the trademarks listed in Schedule A hereto.

Nothing herein shall be construed as affecting the continuing security interest granted by the Company and certain of its Subsidiaries in favor of Morgan pursuant to the Trademark Security Agreement dated October 10, 1996 which was recorded in the United States Patent and Trademark Office as of November 4, 1996, at Reel 1522, Frame 0122, et seq.
