**RELEASE OF SECURITY INTEREST IN TRADEMARKS**


*WHEREAS*, Wampler Foods, Inc. (hereinafter referred to as the "Assignor"), a Virginia corporation, executed and delivered to First Union National Bank, successor to First Union National Bank of Virginia, a national banking association, as Collateral Agent ("Assignee"), a Trademark Security Assignment dated as of February 25, 1998 and recorded in the records of the U.S. Patent and Trademark Office Assignment Division at Reel 1699, Frame 0217, as of March 5, 1998, granting to Assignor a security interest in trademarks as more particularly described in Schedule A attached hereto and incorporated herein by reference (collectively, the "Marks"), and the U.S. Trademark Registration Numbers corresponding to the Marks (collectively, the "Registrations");

*WHEREAS*, pursuant to that certain Revolving Credit Agreement (the "Revolving Credit Agreement") and that certain Term Loan Agreement (the "Term Loan Agreement," and together with the Revolving Credit Agreement, collectively, the "Credit Agreements"; and the Credit Agreements together with all documents referred to therein and executed in connection therewith, collectively, the "Loan Documents"), each dated as of February 25, 1998, by and among the Assignor, WLR Foods, Inc., Cassco Ice & Cold Storage, Inc., Wampler Supply Company, Inc. and Valley Rail Service, Inc., as Borrowers, and the Revolving Credit Lenders and Term Lenders referred to therein (as defined, respectively, in the Revolving Credit Agreement and the Term Loan Agreement and collectively, the "Lenders") and the Assignee, as Agent, all Obligations (as defined in the Credit Agreements) owed by the Assignor to the Lenders under the Loan Documents have been satisfied in full as of November 20, 1998;

*WHEREAS*, as a result of the Assignor's satisfaction of the Obligations, Assignee is desirous of assigning, releasing and quitclaiming to Assignor, without recourse and without representations or warranties of any kind or nature, any right, title and interest, including without limitation any security interest, which Assignee may have in and to the Marks, the goodwill of the business with which the Marks are used, and the Registrations.

*NOW, THEREFORE*, the Assignee has assigned, released, quitclaimed, transferred and set over, and by these presents does hereby assign, release, quitclaim, transfer and set over, unto the Assignor, its successors and assigns, without recourse and without representations or warranties of any kind or nature, any right, title and interest, including without limitation any security interest, which Assignee may have in and to the Marks, the Registrations, and the goodwill of the business in connection with which the Marks are used.
