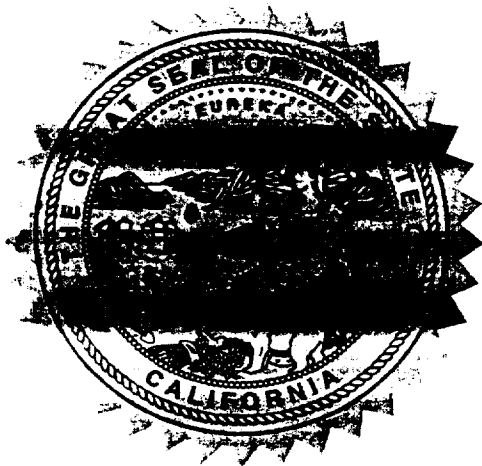

3. That the sole shareholder has adopted said amendment by written consent.




