

THIS RELEASE (TRADEMARK) is given as of this <u>3</u> day of December, 1998 by The Chase Manhattan Bank, a New York banking corporation ("Assignor"), to Volume Services, Inc., a Delaware Corporation ("Assignee"), as follows:
