**SECURITY AGREEMENT**

WHEREAS. Alpine Plant Foods Corporation, an Ontario corporation (the "Assignor"), has adopted, used and is using marks which are registered in the United States Patent and Trademark Office as set forth on **Schedule A** (the "Trademarks");

WHEREAS, the Assignor is the sole owner of the entire right, title and interest in and to the Trademarks and the goodwill of the business symbolized by the Trademarks and the registrations thereof;

WHEREAS, the Assignor has entered into a Loan and Security Agreement dated as of December 1, 1998 (as amended, modified, supplemented or restated from time to time, the "Loan Agreement") by and among the Assignor, Na-Churs Plant Food Company ("Na-Churs"), NationsBank, N.A. and Bank of America Canada ("BofA"), pursuant to which NationsBank and BofA have, on the date hereof, made or agreed to make certain loans to the Assignor or to Na-Churs and may, from time to time hereafter, make additional loans to the Assignor and to Na-Churs; and

WHEREAS, pursuant to the Fixed and Floating Charge Demand Debenture dated as of December 1, 1998 in the principal amount of C\$20,000,000 (the "Debenture"), the Assignor has agreed to assign to BofA, and grant to BofA, a continuing security interest in, and a continuing lien on, all of the Assignor's right, title and interest in and to the following (collectively the "Trademark Collateral"):

- (a) the Trademarks and any other trademarks (including service marks), trade names and trade styles and the registrations and applications for registration thereof and the goodwill of the business symbolized by the trademarks,
- (b) the licenses of the foregoing, whether as licensee or licensor,
- (c) renewals thereof,

(d) income, royalties, damages and payments now or hereafter due and/or payable with respect thereto, including, without limitation, damages, claims and payments for past and future infringements thereof,

(e) rights to sue for past, present and future infringements thereof, including the right to settle suits involving claims and demands for royalties owing, and

(f) all rights corresponding to any of the foregoing throughout the world,

to secure the payment and performance of the Secured Obligations of Assignor (as defined in the Loan Agreement);

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Assignor does hereby assign to BofA, and grants to BofA, a continuing security interest in and a continuing lien on, the Trademark Collateral as security for the payment and performance of the Secured Obligations of Assignor.

The Assignor hereby further acknowledges and affirms that the rights and remedies of BofA with respect to the assignment of and security interest in and lien upon the Trademark Collateral made and granted hereby are more fully set forth in the Debenture, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.

IN WITNESS WHEREOF, the Assignor has caused this Agreement to be duly executed by its authorized officer or agent as of December 18, 1998.


