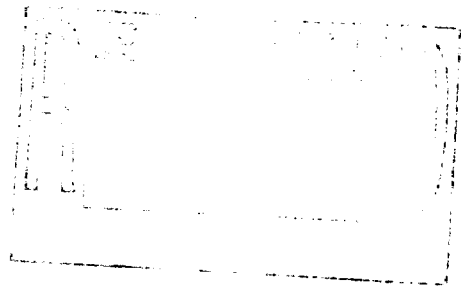

RELEASE OF LIEN
OF
TRADEMARK AND PATENT SECURITY AGREEMENT

This Release of Lien of Trademark and Patent Security Agreement ("Release") is entered into as of ~~November 7~~, 1998 by **AmSouth Bank**, as successor-in-interest to AmSouth Bank of Tennessee, an Alabama banking corporation ("Lender").

WHEREAS, by a certain Trademark and Patent Security Agreement ("Agreement") dated December 4, 1995, and recorded with the United States Patent and Trademark Office on December 13, 1995 in Reel/Fr 1423/0408, **Star Knitwear, LLC**, a Tennessee limited liability company ("Grantor") assigned to the Lender; all of Grantor's right, title and interest in the following: all Trademarks, all Trademark Licenses, all Patents, all Patent Licenses and all Proceeds and products of the foregoing (all as defined in the Agreement), including those listed on Schedule A to the Agreement (collectively the "Collateral"), for the purpose of securing a loan made by Lender to Grantor; and

WHEREAS, the promissory note securing the loan has been paid in full, and there is nothing due or owing on said indebtedness; and

NOW, THEREFORE, in consideration of the above premises, the Lender acknowledges full payment and satisfaction of all obligations which the Agreement secures, and hereby terminates the Agreement and releases the lien on the Collateral evidenced thereby. Lender also releases any and all claims, liens or interests of any nature whatsoever relating in any manner to the Collateral.
