TERMINATION OF SECURITY INTEREST

WHEREAS Lavelle Industries, Inc., a Delaware Corporation having an office at 665 McHenry Street, Burlington, Wisconsin 53105 ("Lavelle"), owns United States Trademark Registration Nos. 769,398 for KORKY; 818,991 for LAVELLE and Design; and 1,731,095 for LAVELLE (collectively "the Trademarks");

WHEREAS Lavelle entered an Assignment, Security Agreement and Mortgage - Trademarks and Patents ("the Security Agreement") on November 30, 1993 with LaSalle National Bank, a national banking association having an office at 120 South LaSalle Street, Chicago, Illinois 60603 ("LaSalle");

WHEREAS, pursuant to the terms of the Security Agreement, Lavelle granted a security interest and mortgage in the Trademarks to LaSalle by way of an Assignment for Security ("Assignment") which was recorded in the United States Patent and Trademark Office on December 2, 1993 at Reel 1088 Frame 0256;

WHEREAS Lavelle has satisfied its obligations under the Security Agreement; and

WHEREAS LaSalle acknowledges that Lavelle has no outstanding obligations under the Security Agreement;

NOW, THEREFORE, LaSalle disclaims any further interest in the Trademarks and hereby terminates the security interest and mortgage that it had taken under the Security Agreement and the Assignment and reassigns to Lavelle any and all right, title, and interest in the Trademarks that it had taken under the Security Agreement and the Assignment.
