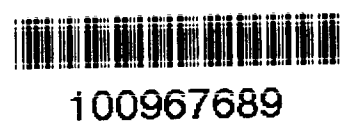



WHEREAS, Assignee has been using the Marks and has previously acquired rights in the Marks from Assignor;


WHEREAS, Assignee wishes to formalize its acquisition of all right, title, and interest in and to the Marks, including the Registrations therefore;
