The Bank has also taken a security interest in various other intellectual property of the Owner including, without limitation, all patents, copyrights and mask works. Collectively all of the Owner's patents, copyrights and mask works are hereinafter the "Miscellaneous Intellectual Property".

The Owner has now repaid the Bank the obligations secured by the Trademark Mortgages, Trademarks and the Miscellaneous Intellectual Property. The Bank has consequently agreed to release its Trademark Mortgages and its security interest in the Trademarks and the Miscellaneous Intellectual Property.

AGREEMENT

The Bank hereby releases and discharges the Owner from all of its obligations under the Trademark Mortgages. In addition, the Bank releases any and all of its security interest in the Trademarks and Miscellaneous Security Interest. To the extent necessary to complete the release, Bank grants and reconveys to Owner (without warranty) any interest it has been previously granted in the goodwill of the Owner and all ancillary rights previously granted to Bank to perfect its security interest in the Trademark Mortgages, Trademarks and Miscellaneous Security Interest.


