WHEREAS, NCS is also desirous of acquiring the Registered Marks and the above-referenced Registrations therefor;

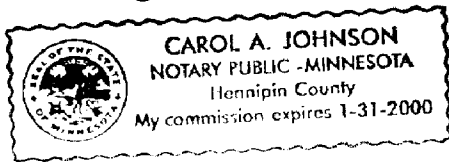

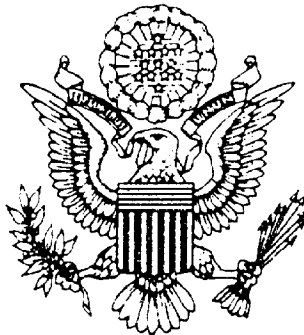
