TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT ("Trademark Assignment") is made as of the 28th day of August, 1997, by and between BISSELL HEALTHCARE CORPORATION, a Michigan corporation, d/b/a SAMMONS™ PRESTON with offices located at 4 Sammons Court, Bolingbrook, Illinois 60440-4989 ("Assignee"), and LANDEC CORPORATION, a California corporation with offices located at 3603 Haven Avenue, Menlo Park, California 94025-1010 ("Assignor").

The parties hereto have executed an Asset Purchase Agreement on even date herewith. All capitalized terms used but not defined in this Trademark Assignment will have the meaning ascribed to them in the Asset Purchase Agreement.

The Asset Purchase Agreement provides, among other things, for the sale and transfer by Assignor to Assignee of the entire right, title and interest in and to the Marks, including those specifically listed on Exhibit A to this Assignment. This Trademark Assignment is made and delivered to perfect such sale and transfer to Assignee of certain of the Marks.

NOW, THEREFORE, pursuant to the Asset Purchase Agreement, and for good and valuable consideration, the receipt and sufficiency of which Assignor hereby acknowledges, Assignor hereby sells, conveys, assigns and transfers to Assignee, and Assignee's successors and assigns, the entire right, title and interest in the United States and in all foreign countries in, to and under the trademark registrations and applications identified in the attached Exhibit A, together with all related common law rights and the goodwill of the business symbolized thereby, together with all rights and privileges granted and secured thereby, including the right to sue and recover for past infringement, these rights to be held and enjoyed by the Assignee, for its own use and benefit and that of its successors, assigns or other legal representatives as fully and entirely as the same would have been held and enjoyed by the Assignor if this Trademark Assignment and sale had not been made.

Assignor represents and warrants that no assignment, sale, agreement, or encumbrance has been or will be made or entered into which would conflict with this assignment, and that Assignor has the legal power to effect the assignment contemplated hereby.

Nothing contained in this Trademark Assignment will in any way amend, supersede, rescind, waive or otherwise affect any provisions, including the representations, warranties, covenants, agreements and limitations, set forth in the Asset Purchase Agreement, this Trademark Assignment being intended only to effect transfer of certain of the Marks to Assignee as provided in the Asset Purchase Agreement.

This Trademark Assignment will be governed by and construed in accordance with the laws of the State of Michigan, without regard to conflict of law principles.

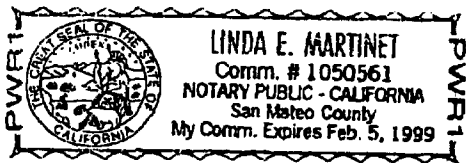
