

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby releases its security interest in all right, title, and interest in the Collateral and reassigns any and all such interests in the Collateral to Assignee. This release and reassignment is made without representation or warranty, expressed or implied, in any event whatsoever.
