Pursuant to the provisions of Section 14A:9-2(4) and Section 14A:9-4(3) Corporations, General, of the New Jersey Statutes, Rheometrics, Inc. (the "Corporation") executes the following Certificate of Amendment to its Certificate of Incorporation:

1. The name of the corporation is Rheometrics, Inc.
2. The following amendments to the Certificate of Incorporation were approved by the Board of Directors, and thereafter, duly adopted by the shareholders of the Corporation on the 10th day of November 1994:

RESOLVED, that Article First of the Company's Certificate of Incorporation be amended in its entirety to read as follows:

FIRST: The name of the Corporation is Rheometric Scientific, Inc.

RESOLVED, that Article Third of the Company's Certificate of Incorporation be amended in its entirety to read as follows:

THIRD: The Corporation is authorized to issue twenty million (20,000,000) shares of Common Stock without par value.

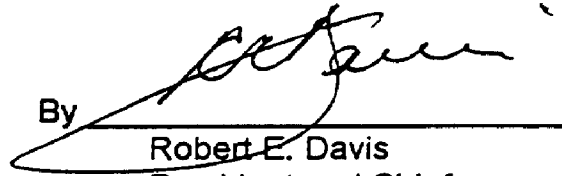
The number of shares voted for the amendment to change the name of the Corporation to Rheometric Scientific, Inc. was 6,562,897; the number of shares voted to abstain was 2,385; the number of shares voted against the amendment was 275.

The number of shares voted for the amendment to increase the number of authorized shares of Common Stock to twenty million (20,000,000) was 6,561,326; the number of shares voted to abstain was 3,496; the number of shares voted against the amendment was 735.
