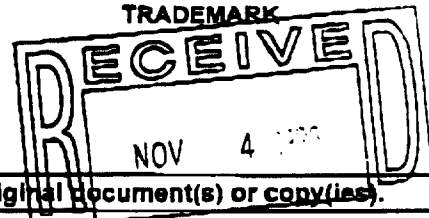

TRADEMARK ASSIGNMENT

WHEREAS, on September 15, 1997, EGS Electrical Group LLC ("EGS"), Emerson Electric Co. ("Emerson"), Apple JV Holding Corp. ("Apple"), General Signal Corporation ("General Signal"), and G.S. Building Systems Corporation ("GSBSC") entered into an Amended and Restated Limited Liability Company Agreement to engage in the Joint Venture Business (as defined therein);

WHEREAS, General Signal formed GSEG LLC ("G1") as a wholly owned subsidiary of General Signal, and O-Z Gedney Company LLC ("G2") as a wholly owned subsidiary of G1, and on September 15, 1997, entered into a Reorganization Agreement in which General Signal and GSBSC contributed to G1 and G2 certain assets relating to the GSEG Business (as defined in the Reorganization Agreement), including certain trademarks and trademark applications which GSBSC contributed to G1;

WHEREAS, on September 15, 1997, EGS, Emerson, and General Signal entered into a Contribution Agreement in which General Signal and GSBSC contributed all of their interests in G1 to EGS for the Joint Venture Business;

WHEREAS, EGS, Emerson, Apple, General Signal, and GSBSC are entering concurrently herewith into a Redemption Agreement to transfer substantially all of the assets and liabilities of the Dual-Lite and Edwards divisions of the GSEG Business (collectively, such divisions are the "Business") back to General Signal and GSBSC in redemption of a portion of General Signal's interest and a portion of GSBSC's interest in

EGS, upon the terms and subject to the conditions set forth in the Redemption Agreement;

WHEREAS, Schedule A, which is attached hereto and incorporated herein by reference, sets forth all trademarks and trademark applications relating to the Business that are owned by G1 ("Assignor") and registered and/or filed in the United States Patent and Trademark Office and/or in trademark offices in other countries;

WHEREAS, GSBSC (the "Assignee") is desirous of acquiring all right, title, and interest in and to each of the trademark registrations and trademark applications identified in Schedule A, together with all good will arising from the use of and symbolized by the trademarks;

NOW THEREFORE, for good and valuable consideration as set forth in the Redemption Agreement, the receipt of which is hereby acknowledged, Assignor and Assignee agree as follows:

1. Assignor hereby sells, assigns, transfers, and conveys to GSBSC all right, title, and interest in and to the trademark registrations and trademark applications identified in Schedule A, together with all good will arising from the use of and symbolized by the trademarks identified in Schedule A.
2. Assignor further agrees to execute upon the request of Assignee such additional documents as are necessary to continue, secure, defend, register, and otherwise give full effect to and to perfect the rights of Assignee under this Trademark Assignment in the trademark registrations and trademark applications identified in Schedule A,

together with all good will arising from the use of and symbolized by the trademarks identified in Schedule A, including all documents necessary to register in the name of Assignee the assignment of each trademark registration and trademark application identified in Schedule A in the respective country or countries identified in Schedule A.

3. Assignor hereby authorizes and requests that the Commissioner of Patents and Trademarks of the United States, and each sovereign official holding a corresponding position of authority in any country within which Assignor has registered trademarks or have pending one or more trademark applications relating to the Business, to issue and to record the title of Assignee as owner of all right, title, and interest in and to the trademark registrations and applications identified in Schedule A, together with all good will arising from the use of and symbolized by the trademarks identified in Schedule A.
