INTELLECTUAL PROPERTY ASSIGNMENT

INTELLECTUAL PROPERTY ASSIGNMENT ("Assignment") dated as of the 30th day of June, 1998, by **BAYER CORPORATION**, an Indiana corporation ("Bayer"), in favor of **BIOCOR ANIMAL HEALTH INC.**, a Delaware corporation ("Biocor").

W I T N E S S E T H:

WHEREAS, Biocor is an indirect, wholly-owned subsidiary of **CSL LIMITED**, an Australian corporation; and

WHEREAS, Bayer and Biocor have entered into an Asset Purchase Agreement dated as of June 30th, 1998 ("Asset Purchase Agreement") which requires the execution and delivery of this Assignment by Bayer for purposes of recording this transfer.

NOW, THEREFORE, TO ALL WHOM IT MAY CONCERN, be it known that for good and valuable consideration, including without limitation consideration previously transferred pursuant to the Asset Purchase Agreement, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound, Bayer agrees as follows:

- 1 Assignment of Marks. Bayer has sold, assigned and transferred, and by these presents does sell, assign and transfer unto Biocor, the full and exclusive right, title and interest, throughout the world, in and to the marks specified in Schedule 1 attached hereto and incorporated herein by this reference, TO HAVE AND TO HOLD unto Biocor, its successors and assigns forever, together with the good will of the business(es) symbolized by such marks, and the registrations thereof specified in said Schedule 1, and the right to recover for any past infringement of said marks.

- 2 Assignment of Other Intellectual Property Rights. Bayer has sold, assigned and transferred, and by these presents does sell, assign and transfer unto Biocor, the intellectual property rights in Seed Organisms and Cell Cultures (as such terms are defined herein), copyrights, copyright registrations, trade names, logos, commercial symbols, industrial designs (including applications for all the foregoing and renewals, extensions, and reissues where applicable), mask works, inventions, trade secrets, formulae, technical information, research data, research raw data and lab notebooks, procedures, designs, know-how, and all other intellectual property owned by Bayer and used exclusively in the Business (as such term is defined herein), TO HAVE AND TO HOLD unto Biocor, its successors and assigns forever, together with any good will of the business(es) symbolized thereby, any registrations thereof, and the right to recover for any past infringement thereof. As used in this Assignment:
 - (a) "Business" shall mean Bayer's canine and feline biologicals business conducted prior to the date hereof exclusively at Bayer's Omaha, Nebraska biological production facility and Bayer's farm at Rushmore, Minnesota.

(b) "Cell Cultures" shall mean (a) batches of primary cells, (b) cell lines, (c) subcultures, and (d) master cell stock, all as defined in 9 C.F.R. 101.6 or any amended or successor regulation and used exclusively in the Business and as required for the 5-way feline combination vaccine.

(c) "Seed Organisms" shall mean (a) master seed, (b) working seed, and (c) production seed, all as defined in 9 C.F.R. 101.7, as the same may be amended from time to time or any successor regulation and used exclusively in the Business and as required for the 5-way feline combination vaccine.

3 Further Assurances. Bayer will from time to time, at Biocor's request and without further consideration, execute, acknowledge and deliver or will cause to be done, executed, acknowledged and delivered all and every such further acts, transfers, conveyances, assignments, and assurances as reasonably may be required for the better using, conveying, transferring, confirming and vesting unto Biocor, its successors and assigns, of the intellectual property rights specified herein, and for aiding and assisting Biocor, its successors and assigns, in the use and exploitation of such intellectual property rights.

4 Successors and Assigns. This Assignment is executed by and shall be binding upon Bayer and its successors and assigns, and shall inure to the benefit of Biocor and its successors and assigns.

5 Governing Law. This Assignment shall be governed by and construed in accordance with the laws of New York without regard to conflict of laws principles thereof.

6 Severability. If any term, covenant or condition of this Assignment shall, to any extent, be invalid, illegal or unenforceable, the remaining provisions shall not in any way be affected or impaired thereby and each term, covenant or condition of this Assignment shall be valid and enforceable to the fullest extent permitted by law.
