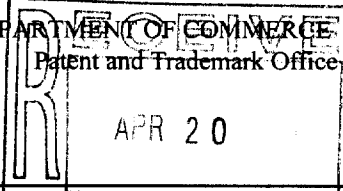

RELEASE AND TERMINATION OF
PATENT AND TRADEMARK SECURITY AGREEMENT

RELEASE AND TERMINATION OF PATENT AND TRADEMARK SECURITY AGREEMENT, dated as of February 19, 1998 (this "Agreement"), by and between MICHAEL STEVENS LTD., a New York corporation ("Stevens"), and BANKBOSTON, N.A. (formerly known as The First National Bank of Boston), as agent of the Lenders (in such capacity, the "Agent"), under (and as defined in) the Revolving Credit Agreement referred to below.

WHEREAS, Stevens and Etienne Aigner, Inc., a Delaware corporation (collectively, the "Borrowers") have entered into a Revolving Credit Agreement, dated as of July 1, 1996 (the "Credit Agreement"), providing, subject to the terms and conditions thereof, for extensions of credit to be made by the Lenders to the Borrowers (capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Credit Agreement);

WHEREAS, as security for the Borrowers' Obligations, Stevens entered into a Patent and Trademark Security Agreement, dated as of July 1, 1996 (the "Stevens PT Security Agreement") pursuant to which Stevens granted security interests in certain collateral (including the trademarks, trademark applications, patents and patent applications described on Schedule I hereto) to the Agent for the benefit of the Lenders;

WHEREAS, copies of the Stevens PT Security Agreement were recorded with the United States Patent and Trademark Office on July 9, 1996 at Reel 1494, Frame 0517 and at Reel 8095, Frame 0207.

WHEREAS, pursuant to an Agreement and Amendment No. 4, dated as of December 15, 1997, the Borrowers, the Agent and the Lenders have agreed that upon the payment in full of all outstanding Obligations of Stevens, Stevens shall no longer be a party to the Credit Agreement and other Loan Documents and the Agent shall release its security interest in all of the Collateral of Stevens;

NOW, THEREFORE, in consideration of these premises, and the mutual covenants and agreements contained herein, the parties hereto agree as follows:

1. Release of Collateral. The Agent hereby terminates and releases its security interests in all of the Collateral (as defined in the Stevens PT Security Agreement), including, without limitation, the trademarks, trademark applications, patents and patent applications described on Schedule I attached hereto, and hereby assigns and transfers to Stevens, without recourse, all of the Agent's right, title and interest in and to such Collateral.

The Agent and Stevens hereby agree that the Stevens PT Security Agreement is terminated.

2. Miscellaneous. This Agreement shall be governed by and construed in accordance with the laws of The Commonwealth of Massachusetts (without regard to conflicts of laws principles). This Agreement may be executed in several counterparts and by each party on a separate counterpart, each of which when so executed and delivered shall be an original, but all of which together shall constitute one instrument.
