**TRADEMARK ASSIGNMENT OF SECURITY**

WHEREAS, Border Foods, Inc., a corporation formed under the laws of Texas, located at J Street, Deming Industrial Park, Deming, New Mexico 88030 ("Borrower"), has adopted, used and is using the marks shown in the attached Schedule A (the "Marks"), for which there are registrations or applications in the United States Patent and Trademark Office under the numbers shown in the attached Schedule A; and

WHEREAS, Borrower is obligated to Agent and Lenders (terms hereinafter defined) pursuant to (i) a certain Second Amended and Restated Loan and Security dated as of July 31, 1998, among Borrower and LaSalle Business Credit, Inc. ("LaSalle"), FINOVA Capital Corporation ("FINOVA"), the various other financial institutions which hereafter become a party thereto (LaSalle, FINOVA and such other financial institutions, collectively, the "Lenders") and LaSalle, as agent for Lenders (LaSalle in such capacity, "Agent") and (ii) a certain Trademark Collateral Security Agreement, dated as of July 31, 1998, made by Borrower in favor of Agent for the ratable benefit of Agent and Lenders (as each may be amended, modified, restated or supplemented from time to time, collectively, the "Agreements"); and

WHEREAS, pursuant to the Agreements, Borrower is granting to Agent and Lenders a security interest in the Marks, the goodwill of the business symbolized by the Marks, and the registrations and applications therefor.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Borrower does hereby assign unto Agent and grant to Agent for the ratable benefit of Agent and Lenders a security interest in and to the Marks, together with the goodwill of the business symbolized by the Marks, and registrations and applications therefor, which assignment and security interest shall secure all the Obligations as defined in the Agreements and in accordance with the terms and provisions thereof.

Borrower expressly acknowledges and affirms that the rights and remedies of Agent with respect to the assignment and security interest granted hereby are more fully set forth in the Agreements.
