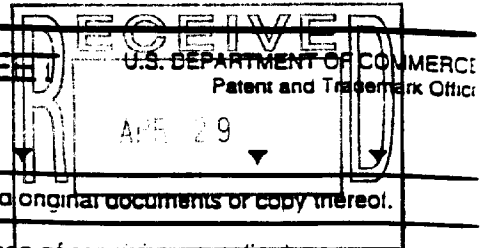

RELEASE
