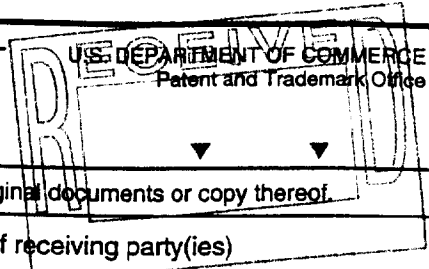



THIS ASSIGNMENT having an effective date of June 17, 1994, is made and entered into as follows:
