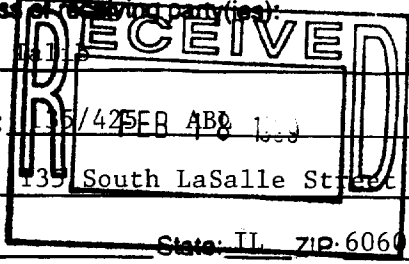

**AMENDMENT NO. 1 TO
TRADEMARK SECURITY AGREEMENT**

THIS AMENDMENT NO. 1 ("Amendment") to that certain **Trademark Security Agreement** dated as of April 21, 1998 (the "Trademark Security Agreement") made by **National Electronics Acquisition Corp.**, a **Florida** corporation (the "Borrower") in favor of LaSalle National Bank, with an office at 135 South LaSalle Street, Suite 425, Chicago, Illinois 60603 (the "Lender") is made as of **February 8**, 1999.

WHEREAS, the Borrower and Lender are parties to that certain Loan and Security Agreement dated as of **April 21, 1998**, as it may be amended from time to time, pursuant to which the Lender has agreed to extend loans and certain other financial accommodations to the Borrower and the Borrower has granted to the Lender a security interest in substantially all of the Borrower's assets, including, without limitation, its trademarks, trademark applications, tradenames, service marks, service mark applications and goodwill (collectively, "Trademarks");

WHEREAS, the Trademark Security Agreement was duly recorded in the United States Patent and Trademark Office on **May 13, 1998**, Reel/Frame #**1726/0517**, in the form attached hereto as Exhibit 1.

WHEREAS, since the date of the Borrower's execution of the Trademark Security Agreement, the Borrower has changed its name to **National Electronics, Inc.**; and

WHEREAS, the parties agree to amend the Trademark Security Agreement to confirm the change of name of Borrower to **National Electronics, Inc.**;


NOW, THEREFORE, for good and valuable consideration, the receipt and legal sufficiency of which are hereby acknowledged, the parties hereto hereby agree to amend the Trademark Security Agreement as follows:

1. Name Change. All references to **National Electronics Acquisition Corp.** shall be deemed to refer to **National Electronics, Inc.**

2. Effect of Amendment. Except as expressly amended by this Amendment, the terms of the Trademark Security Agreement shall remain in full force and effect as executed.


