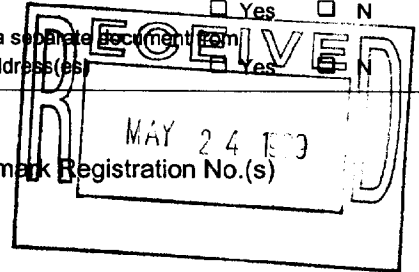

TRADEMARK

TRADEMARK AND SERVICE MARK ASSIGNMENT

This TRADEMARK AND SERVICE MARK ASSIGNMENT, effective this 17th day of May, 1999 by and between STONE CONTAINER CORPORATION, a Delaware corporation, having an office and principal place of business at 150 North Michigan Avenue, Chicago, Illinois 60601 (hereinafter sometimes referred to as "ASSIGNOR") and SMURFIT-STONE CONTAINER CORPORATION, a Delaware corporation, having a principal place of business at 150 North Michigan Avenue, Chicago, Illinois 60601 (hereinafter sometimes referred to as "ASSIGNEE"). For good and valuable consideration, the sufficiency and receipt of which is hereby acknowledged, and in compliance with the obligations of the Nunc Pro Tunc Trademark License and Assignment Agreement effective as of November 18, 1998, ASSIGNOR hereby transfers, assigns and conveys to ASSIGNEE, ASSIGNOR's entire worldwide right, title and interest in, together with the goodwill of the business symbolized by, the trademarks, service marks, trade names, trademark applications and service mark applications anywhere in the world, and any and all U.S. and foreign trademark and service mark registrations that issue therefrom, (collectively, the "SSCC Marks") respectively set forth in Schedule A attached hereto and made a part hereof; together with all renewals thereof; all income, royalties, damages and payments now and hereafter due and/or payable with respect thereto, including, without limitation, damages and payments for past or future infringements thereof.

Together with ASSIGNOR's entire right, title and interest in, as well as the goodwill of the business associated with the SSCC Marks listed in Schedule A, are any and all rights and privileges in the United States as well as throughout the entire world associated with same, including the right to sue for any and all past infringement which may have occurred at any time up to the date of this TRADEMARK AND SERVICE MARK ASSIGNMENT.

ASSIGNOR hereby covenants and warrants that it has the full right to convey the above-described worldwide right, title, interest, and goodwill by this instrument, in furtherance of the Nunc Pro Tunc Trademark and Assignment Agreement set forth hereinabove, and in full compliance with its obligations thereunder; free of any


encumbrances and that no other agreement has been or will be executed in conflict herewith.

ASSIGNOR agrees to perform all affirmative acts which may be necessary or desirable to perfect the above-described transfer of the SSCC Marks to ASSIGNEE and to maintain said applications and/or registrations before both the United States Patent and Trademark Office and the Trademark Offices of any and all foreign countries, as well as to cooperate in obtaining and/or providing information required in any proceedings relating to said trademarks, service marks and trade names.
