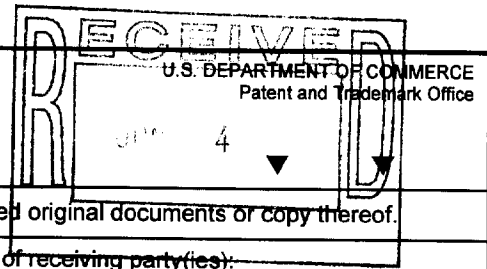

## TRADEMARK ASSIGNMENT

This Trademark Assignment is made as of May 17, 1999, by Morton International, Inc., an Indiana corporation, with its principal office located at 100 North Riverside Drive, Chicago, Illinois 60606 ("Assignor"), to TMT – Pathway, LLC, a Delaware limited liability company with its principal office located at 2997 Clarkson Road, Chesterfield, Missouri 63017 ("Assignee").

A. Assignor is the current owner of the trademarks and the United States and foreign trademark registrations set forth on Exhibit A hereto (the "Trademarks").

B. Assignor acquired all of the Trademarks (other than the U.S. applications for "Legend-Build", filed in September 1998 and "Storm-Line", filed in May 1999) pursuant to an Assignment and Assumption Agreement executed April 30, 1997 (the "April 1997 Agreement"), in which a corporation known as Morton International, Inc. (a separate corporation from Assignor, and referred to herein as "Old Morton") assigned such Trademarks to New Morton International, Inc., now known as Morton International, Inc., the Assignor herein. Neither the April 1997 Agreement nor any documents evidencing that assignment of the Trademarks were recorded with any trademark office.

C. Beginning in May 1997, through inadvertence, the United States Trademark Office was asked to and did record against the Trademarks (other than "Legend-Build" and "Storm-Line") a Certificate of Fact evidencing the merger and change of name, effective May 1, 1997, from Old Morton to Autoliv ASP, Inc., and a May 21, 1997 Assignment from Autoliv ASP, Inc. to Assignor (the "Autoliv Assignment"). The United States Trademark Office was also asked to record an Assignment from Autoliv ASP, Inc. to Morton executed as of March 3, 1999 ("the March 1999 Assignment").

D. Also through inadvertence, the Canadian Trade-Marks Office and Trademark Office in Mexico were asked to record the Certificate of Fact and Autoliv Assignment.

E. The Certificate of Fact, Autoliv Assignment and March 1999 Assignment in fact had no bearing on the Trademarks because Assignor already owned the Trademarks pursuant to the April 1997 Agreement.


F. Assignor desires to assign to Assignee, and Assignee desires to acquire from Assignor, all of Assignor's right, title and interest in and to the Trademarks.



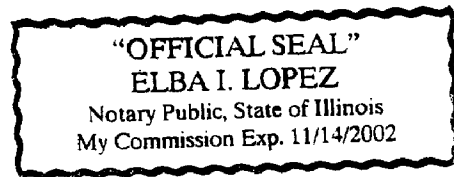

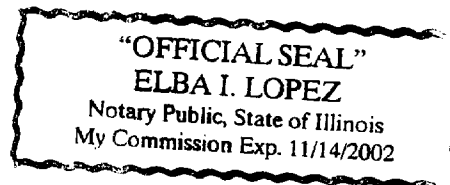
