TRADEMARK ASSIGNMENT

THIS AGREEMENT is made this 18th day of September 1998, between Acme Boot Company, Inc., a Delaware corporation ("Assignor") and Lucchese, Inc., a Delaware corporation ("Assignee").

WHEREAS, in furtherance of the transactions contemplated by the Asset Purchase Agreement, dated as of June 26, 1998, by and among Acme Boot Company, Inc., Acme Footwear Company, Inc., Lucchese Retail Co., Inc., and Lucchese, Inc., Assignee wishes to acquire all of Assignor's right, title and interest in and to the trademarks listed in Schedule A attached hereto (the "Marks"), and the registrations and applications thereof, and the goodwill associated therewith;


NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Assignor hereby assigns, transfers, and conveys unto Assignee, as successor to Assignor's business, all of its rights, title and interest in and to the Marks, whether statutory or at common law, including all registrations and applications thereof, together with the existing and ongoing business to which the Marks pertain as well as the goodwill of the business symbolized by the Marks, and the right to sue for, collect and retain all damages and profits and all other remedies for past infringements thereof.

ASSIGNOR agrees to execute any further papers and to do such other acts as may be necessary and proper to vest full title in and to the Marks and the good will of the business symbolized by the Marks, and the registrations and applications thereof.

The Commissioner of Patents and Trademarks of the United States is requested to issue the Certificates of Registration for the pending Marks to the Assignee upon registration.
