CONFIRMATORY ASSIGNMENT

NUNC PRO TUNC

as of

THIS CONFIRMATORY ASSIGNMENT confirms *nunc pro tunc* as of June 30, 1998, the assignment of trademarks, applications to register trademarks, trademark registrations, trade names, rights in certain inventions, applications to obtain letters patents, letters patents, and all other intellectual property owned by Assignor (collectively "intellectual property"), together with that part of the goodwill of the business connected with the use of said intellectual property and symbolized thereby, and assignment of all rights to sue, to arbitrate, and otherwise to enforce legal rights in such intellectual property, by:

(a) Jacuzzi Inc., a former Delaware corporation, which had its principal place of business at 2121 North California Blvd., Suite 475, Walnut Creek, California, as Assignor,

to:

(b) Jacuzzi Inc., a Delaware corporation, with a principal place of business at 2121 North California Blvd., Suite 475, Walnut Creek, California, as Assignee.

In this Confirmatory Assignment, the word "trademark(s)" includes both marks applicable to goods and marks applicable to services.

BE IT REMEMBERED that as of June 30, 1998, all of the assets of Assignor, including without limitation the following described intellectual property and appurtenant rights, were transferred to Assignee:

(a) All of the entire right, title, and interest in and to trademarks, applications to register trademarks, trademark registrations, and trade names, both registered and

unregistered, including all Notices of Allowance and all Certificates of Registration relating thereto, and all other proprietary designations;

(b) All of the entire right, title, and interest in and to certain inventions and in and to pending applications to obtain letters patents and issued letters patents;

(c) All rights to sue, arbitrate, or otherwise enforce, at its sole option in its own name or in the name of Assignor, its rights for past and present misuse or infringement of said intellectual property; and,

(d) All of the goodwill of the business appurtenant to said intellectual property.

NOW THEREFORE, pursuant to the June 30, 1998 transfer, the occurrence of which is hereby confirmed and acknowledged, Assignor does hereby confirmatorily sell, assign, transfer, and set over *nunc pro tunc* as of that date to Assignee:

(a) the entire right, title, and interest in and to the intellectual property herein described and enumerated;

(b) the goodwill and the business in connection with said intellectual property; and,

(c) rights to institute legal proceedings at law or in equity, or to engage in arbitration, at its sole option in its own name or in the name of Assignor, to (1) to obtain injunctions against, and/or to recover monetary damages for, past, present, or future infringements of any or all of said trademarks or trade names, or (2) to obtain injunctions against, and/or to recover monetary damages for, past, present, or future infringements of any or all of said inventions or letters patents, including each and all of the trademark registrations, applications to register trademarks, letters patents, and applications to obtain letters patents, set forth in the following appendices attached hereto and made a part hereof:




