**RELEASE OF SECURITY INTEREST AND COLLATERAL  
ASSIGNMENT OF TRADEMARKS AND OTHER COLLATERAL**

This RELEASE OF SECURITY INTEREST AND COLLATERAL ASSIGNMENT OF TRADEMARKS AND OTHER COLLATERAL, dated as of August \_\_, 1998, by STATE STREET BANK AND TRUST COMPANY, N.A., as agent ("Agent") for STATE STREET BANK AND TRUST COMPANY, N.A. in its capacity as Trustee ("Trustee") under the Indenture, dated as of August 7, 1997 between the Trustee and the Grantor (as defined below)(as amended, supplemented or otherwise modified from time to time, the "Indenture"), grants a release of security interest and collateral assignment to WRIGHT MEDICAL TECHNOLOGY, INC. (the "Grantor") as follows:

**WITNESSETH:**

WHEREAS, the Grantor, the Agent and the Trustee have entered into various relationships, including, but not limited to, a security agreement recorded in the U.S. Patent & Trademark Office on August 11, 1997, at Real and Frame No. 1620/0945 (the Security Agreement) and the Indenture;

WHEREAS, the Security Agreement granted to Agent on behalf of Trustee a security interest in certain of the Grantor's assets, including, without limitation, certain trademarks and other collateral described in the Security Agreement which descriptions are incorporated herein;

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Agent agrees as follows:

1. Agent hereby releases, sells, assigns, transfers and sets over the entire right, title and interest in the trademarks and trademark applications listed in Schedule A attached hereto, including all goodwill relating thereto, and declares as null and void all liens, security interests, and other claims, including any claim of ownership, of Agent with respect to those trademarks and trademark applications listed in Schedule A arising from the Security Agreement and any other commercial credit relationships, or otherwise.

2. This RELEASE of security interest and collateral assignment has been executed and delivered by Agent for the purpose of releasing, removing, or otherwise eliminating the security interest and collateral assignment of Agent in the trademarks and trademark applications listed in Schedule A that has been filed with the United States Patent and Trademark Office and, to the extent required, any other such offices in other countries of the world.

3. A true and correct copy of the list of the trademarks and trademark applications is attached hereto as Schedule A.

4. Agent has a continuing obligation to sign all agreements, documents, or otherwise, necessary to carry out this Agreement and the obligations herein.
