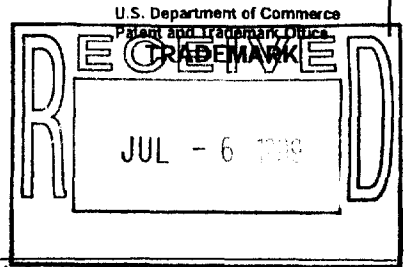

Assignee will pay the future costs of filing with the U.S. Patent and Trademark Office.

This Trademark Assignment shall be binding upon the successors, assigns, nominees, or other legal representatives of Assignor.
