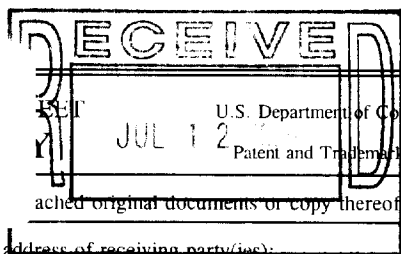

RELEASE OF TRADEMARK AND COPYRIGHT COLLATERAL

THIS RELEASE OF TRADEMARK COLLATERAL (this "Release") is made as of March 26, 1999, by FLEET CAPITAL CORPORATION ("Fleet"), the secured party under that certain Security Agreement referred to below.

WITNESSETH:

WHEREAS, Thomas Bros. Maps, a California corporation ("Borrower"), executed that certain Security Agreement (Intellectual Property) (the "Security Agreement") dated as of February 11, 1997 pursuant to which Borrower granted a security interest to Fleet in certain trademarks, copyrights and other intellectual property of Borrower; and

WHEREAS, said Security Agreement was recorded with the Assignment Branch of the United States Patent and Trademark Office on February 21, 1997 at Reel 1538, Frame 0852; and

WHEREAS, said Security Agreement was recorded with the Copyright Office of the United States on February 28, 1997 at Volume 3346, Page 279 through 284; and

WHEREAS, Fleet has agreed to release all its rights under such Security Agreement, including in the trademarks, copyrights and applications therefor identified on Exhibit A attached hereto and made a part hereof (the "Released Collateral"), and to reconvey any and all rights in the Released Collateral to Borrower.

NOW, THEREFORE, in consideration of the premises and other good and valuable consideration, receipt of which is hereby acknowledged, Fleet hereby releases all its rights in and to the Released Collateral, reconveys to the persons legally entitled thereto all of Fleet's right, title and interest in and to the Released Collateral, releases all other rights it may have under said Security Agreement with respect to the Released Collateral and cancels such Security Agreement in its entirety, all without warranty or representation of any kind.

IN WITNESS WHEREOF, Fleet has caused this Release to be duly executed on the date first above written.



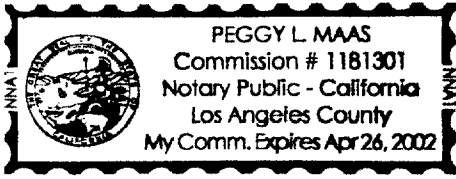
