

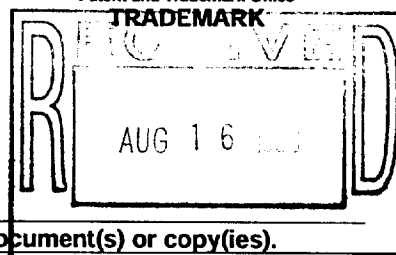

RELEASE OF SECURITY INTEREST

IN PATENTS AND TRADEMARKS

WHEREAS, REVERE COPPER PRODUCTS, INC., a Delaware Corporation ("Revere") is the owner and registrant of record in the U.S. Patent and Trademark Office of the Patents and Trademarks set forth respectively in Schedules A and B attached hereto and made a part hereof, together with the good will of the business symbolized by said trademarks and the registrations of and applications for said patents and trademarks (collectively the "Intellectual Property").

WHEREAS, pursuant to a Financing Agreement dated June 2, 1993 and a separate Financing Agreement dated May 17, 1994 (collectively the "Financing Agreements"), ITT Commercial Finance Corp., a Nevada corporation ("ITT"), made certain loans and financial accommodations to Revere.

WHEREAS, pursuant to a Grant of Security Interests and a Collateral Assignment of Patents, Trademarks, and Licenses dated as of June 2, 1993 (the "Security Agreement"), Revere mortgaged, pledged and granted to ITT a security interest in all of Revere's right, title and interest in, to and under any and all past, present and future patents, trademarks, technology and know-how, and all licensees, royalties, and all other monies relating thereto, including but not limited to the Intellectual Property.

WHEREAS, the Security Agreement was duly recorded in the United States Patent and Trademark Office.

WHEREAS, ITT was later acquired by General Electric Capital Corporation ("GE Capital") with its offices at 11590 Century Boulevard, Suite 111, Cincinnati, Ohio 45246.

WHEREAS, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, General Electric Capital Corporation intending to be legally bound, hereby releases and discharges unto Revere Copper Products, Inc., all of its right, title and interest, including but not necessarily limited to any and all security interests, that it now has, has ever had or may hereafter have in, to and under any and all past, present and future patents, trademarks, technology and know-how, and all licenses, royalties and other monies relating thereto, including but not necessarily limited to, each of the patents and trademarks set forth, respectively, in Schedules A and B attached hereto, together with the good will of the business symbolized by said trademarks and the registrations of and applications for said patents and trademarks pending in the United States Patent and Trademark Office.
